Both presentations were helpful to all.

- FRAS 2007: Will be hosted by the University of Central Florida in Orlando, January 26th-30th, 2007!
- FRAS 2006: Embry-Riddle Aeronautical University hosted FRASCAR 2006 in Daytona Beach from January 20th-22nd. There were 24 schools in attendance, and 354 total participants (307 delegates and 47 advisers) an all-high in attendance in the past 4 years. There were 55 program offerings for delegates and 5 sessions for advisers. The overall top programming award recognized Nicolette Imam, Stephanie Garland and Tamara Marryshow from FIU for “Family Feud: Revving up the spark on your Team! New Programs, Innovations, Etc.:

- Florida State University: We have instituted a new programming model called the BRIDGE (Building Residents by Intentionally Developing Guided Experiences) Model. It focuses on monthly hall wide, floor based and passive programming methods centering around the five tenets present in our new mission statement in Residence Life: "Residence life facilitates the development of every resident through the promotion of responsible citizenship, learning, appreciation of differences, personal wellness, and involvement." It is our hope that by centering on each tenet through active and passive programming initiatives we will be able to drive these core value themes home to the residents to help shape their experiences in living with us. We intend to look at the model throughout the year to see what tweaks we need to add to it including the potential of some type of points based initiative to recognize continued achievement by individual staff members and teams. We have implemented several changes to our staffing patterns in residence life this year including the addition of more masters level professional staff members and the refocusing of some professional positions to concentrate on areas that need more specific attention in our system. We have one professional staff member in charge of Rogers and McCollum Halls (both upper-class apartment facilities) and serving as the advisor to both IRHC (our RHA here at FSU) and NRHH. We are looking to this person to help grow our young leaders in these vital student organizations to be better equipped to represent the students on campus as an agency of SGA and more intentional in the programming and support efforts campus-wide. We have begun operating Dorman and Deviney Halls as a complex providing additional leadership over there for the first year students and RAs serving in those two halls. Finally, we have continued to expand the skills of some of our full time professionals by giving them opportunities to chair significant initiatives in our system including working with our residence life judicial boards and judicial database system, hall life improvement committee, staff recognition, and training and selection committees.
- University of Florida: Residence Life and Education designed and implemented new community development model for graduate and family housing and single-student housing, which includes a weekly compass point/topic of discussion. Each point of the compass coincides with programmatic focus areas (N- Navigating University Life, S- Scholarship, E-Establishing and maintaining relationships, W- World Awareness). Graduate and Family Housing has implemented new administrative procedures to include: a health and safety inspection, 45-day notice to vacate, reduced turn-around time for apartment readiness. Administrative Services has implemented an online application process for graduate and family housing and single-student housing. We opened the Global Learning Community at Yulee Hall for Fall 2006. Academic Initiatives and Enhancement implemented study buddy program for entire undergraduate housing population for Fall 2006. Residence Life and Education staff participated in campus training initiative: QPR suicide prevention, as a collaborative effort with our Counseling Center. Administrative Services completed a network upgrade and moved from a 10/100 megabit to a 1 gigabit connection at the pillow in single-student housing. Facilities staff completed renovation of a 200 bed residence hall, installation of a fire suppression system in a 250 bed residence hall and replacement of elevator in a 14-story tower residence hall.

Problems:

- We continue to be challenged by the ever-changing landscape of technology, development of budget processes which support by our long-range planning, the continual drain on Auxiliary budgets to fund non-Housing related expenses and initiatives, aggressive building programs, competitive off-campus markets, higher expectations from students and their parents, and establishing best practices to support sustainability efforts. We consider ourselves very lucky to have avoided severe weather patterns thus far, as many communities remain "under construction and renovation" from the 2004 and 2005 hurricane seasons.
